

## OFFICIAL RULES OF THE CHRIS STAPLETON'S ALL AMERICAN ROAD SHOW FLYAWAY SWEEPSTAKES

**NO PURCHASE IS NECESSARY TO ENTER FOR A CHANCE TO WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**Eligibility:** The Chris Stapleton's All American Road Show Flyaway Sweepstakes ("Promotion") is open only to natural persons who are legal residents of the United States of America or Canada (except Quebec) who have a valid social security or tax ID number, and who are at least eighteen (18) years of age at the time of entry. Promotion may only be entered from and in eligible jurisdictions. Promotion Entities, prize providers, and their respective parent, subsidiary and affiliate companies, employees, agents, and suppliers, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to participate. For Friend Referral to be valid, entrant must use the Share icons or the Personal Referral link on the Confirmation Thank You page that will display upon successful entry.

**For all entries:** Each participant is eligible to submit up to one (1) Promotion entry during the Promotion Period, regardless of method or combination of methods of entry or number of entries submitted. Each participant may also receive a maximum of two (2) additional entries via Friend Referral. Total entries into the Promotion not to exceed three (3) per participant. **Prize:** One (1) Grand Prize consisting of an All American Road Show Flyaway VIP Experience to see Chris Stapleton which includes two (2) reserved tickets to see Chris Stapleton at BB&T Pavilion in Camden, NJ scheduled to take place on August 12, 2017, to include two (2) VIP Passes to The 78' Pre-Show Lounge and Interactive Experience; round-trip, coach class air transportation for two (2) from the airport nearest Grand Prize Winner's home within the U.S. or Canada to Philadelphia, Pennsylvania departing on August 11, 2017 and returning on August 13, 2017; one (1) double occupancy standard hotel room for two (2) nights / three (3) days; and a 200.00 cash gift card.
